## REPORT OF THE INSPECTION COMMITTEE CONSTITUTED FOR INSPECTION OF VIMAL MUNI COLLEGE OF EDUCATION, BARA, VIJAYPUR (SAMBA), FOR RENEWAL/ EXTENSION OF TEMPORARY AFFILIATION FOR THE SESSION 2023-24.

In pursuance of letter No. CDC/2023/3798-800 dated 24.11.2023, the Committee constituted vide order No. CDC/2023/6373-379 dated 27.03.2023 inspected the college on 30.11.2023 for renewal/extension of temporary affiliation for the session 2023-24. Prof. Jasbir Singh, Department of Economics could not join the team due to other engagement.

Soon after arrival, the college presented a power point presentation highlighting the objectives of the college and infrastructure raised by it. After the preliminary interaction with the Principal and faculty members, the committee scrutinized the record produced by the college. There are 30 candidates on roll against the intake capacity of 100 seats. The college has appointed nine faculty members (including Principal) on regular basis and one faculty member on adhoc basis. The intake capacity of the college is 100 seats and as per norms the college has to appoint 16 faculty members. The college is short of six faculty members. The college management was directed to appoint adequate teaching faculty as per norms on an immediate & urgent basis.

Last meeting of the Management Committee was conducted on 17.01.2023 and it was observed that the college is regular in convening the meeting of the Managing Committee. The college has constituted various committees as per norms.

The committee also took a round of the library, Computer Lab. The college appointed the Librarian on adhoc basis. Books procured during the current financial year are not as per syllabi. The college was directed to procure more books as per syllabi of the reputed authors as suggested by the subject experts. The college was also asked to initiate the process to make the Library on fully automation mode and the Librarian was asked to produce an archive of the education related clipping in a separate folder. The college management was also requested to install atleast two computers with latest configuration in the Library with Wi-Fi connection for the students.

## Recommendations:

The committee recommends that temporary affiliation of the college for the session 2023-24 be extended. However, the college be directed to appoint adequate teaching staff and Librarian as per norms through proper selection committee with in a period of 30 days.
